Five Petitions of the Municipalité des Escoumains; praying for a free grant of land to the people living on the Tadousac and Portneuf Roads,—also praying for the crection of a Light-House at Portneuf (en bas),—also praying for aid for the completion of certain roads,—also praying for the appointment of a Coroner for the County of Saguenay,—and also praying for certain amendments to the Fishery Laws, so as to allow proprietors to erect fisheries on their properties, free.

Of the Reverend Julien Rioux and others, of St. François Xavier dite la Petite Rivière; and of Wm. Innderson and others, of East Frampton, in the County of Dorchester; severally praying for aid for the completion and opening of certain roads.

Of George H. Low and others, of the Parish of Darlington; praying against the pasing of the Bill for the sale of the Glebe lots of land in Darlington.

And of *Rowland Burr*, of the City of *Toronto*; praying for the amendment of the Grammar School Act, so that he may be paid the amount due him for the construction of the Grammar School House at *Weston*.

The Honorable the Speak r presented to the House a Return of the Baptisms, Marriages and Burials for the County of *Montcalm*, for the year 1864.

Ordered, That the same do lie on the table, and it is as follows :--

QUEBEC, December 29th, 1864.

No. 199—Dec. 17th. SIR,—Referring to my Despatches, noted in the margin, I have the "202—"20th. honor to report, that in pursuance of the General Order of the 19th Decomber. the thirty Companies of Volunteers called out for duty have been

embodied in three Administrative Battalions of ten Companies cach, the Head-quarters of which are stationed respectively at Windsor, Niagara and La Prairie.

The Companies are all sixty-five strong, exclusive of officers.

You will perceive by the copies of the several General Orders, that the Companies have been so selected as to give all parts of the Province an opportunity of contributing to the force embodied.

I have also so arranged that the Volunteers from Eastern Canada should, as much as possible, be stationed in Canada West, and vice vers \hat{a} .

These modes of proceeding caused some slight delay in getting the force to its destination, but I think it is not a little creditable to the Volunteers and to those who conducted the arrangements, that the first intimation the force received that their services would be required was by the General Order of December 19th, and that the three Battalions are now at their respective stations; some of the Companies of which they are composed having had to travel a distance of nearly seven hundred miles, in order to reach their destinations.
