

This morning paper, which up till now has subsisted only by virtue of its cheapness in price, cannot but be worsted in a struggle with so formidable an opponent.

"To even so much as compare The World and The Mail and Empire as advertising mediums, or as vehicles of information, is to do an injustice to the latter. In outward form and appearance, in literary style and tone, in foreign, provincial and local news, the vast superiority of The Mail and Empire has always been conceded. The advertising columns of to-day tell the tale of tomorrow, and it will be interesting for observers to watch deserting ads. leave their chief in his downfall, only to reappear in the ranks of a worthier and more powerful friend."
