# CARD SYSTEM FOR DRUG DISTRIBUTION TO INDIANS

Further to his reply to a question a few days ago about the replacement of the list system for Indians entitled to free drugs with a card system, will the minister say what target date has been set for this change and, if none has been set, will he undertake to report to the house on this matter?
