HIGHWAY SAFETY

PROTECTION OF CANADIAN CONSUMERS FROM TIRE FAILURE

I ask whether, in view of the results of tests on tires in the United States, recently released by the United States government, in which it was found that 18 per cent of the tires tested failed to meet safety requirements, the minister would consult with his colleague the Minister of Transport in order to assure us that Canadian consumers will have safety in respect of tires.

Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, this question should properly be directed to the Minister of Transport, whose ministerial responsibility includes this area. The Minister of Transport will be in the house tomorrow. I will, of course, as always, consult with him when it is a question involving consumers.
