Regular publications entitled "Supply and Demand of New University Graduates" and "Requirements and Average Starting Salaries" contain sample results on the labour market status of new university graduates. Projections of requirements for Managerial, Professional and Technical classes are contained in the publication "A Projection of Manpower Requirements by Occupation in 1975". Another publication "Canada's Highly Qualified Manpower Resources" indicates the education and employment patterns of scientists and engineers.
