**Hon. Arthur Laing (Minister of Public Works):** 1. Plans to extend the federal building were initiated on August 11, 1967. It was anticipated that an addition might be required at some future date so vacant land was purchased for this purpose on February 1, 1963, at a total cost of \$17,202.56 for land, survey, and legal fees.

2. Plans for the extension were abandoned on January 28, 1969. The total cost was \$21,202.56 including an estimated amount of \$4,000. for the preparation of plans and specifications by the departmental staff.

2. What is the projected total for 1970 in each country?

**Mr. Bruce Howard (Parliamentary Secretary to Minister of Industry, Trade and Commerce):** In so far as the Dominion Bureau of Statistics is concerned: 1. The total book value of private Canadian direct investment in the Republic of South Africa and Namibia at each year end from 1963 to 1969 is shown below:

Investment in Namibia historically has been included with totals for the Republic of South Africa. The Namibia share of the \$70 million shown above for 1969 reached a total of almost \$2 million at the end of the year. As investment in this territory prior to 1969 was concentrated in one company, the confidentiality provisions of the Statistics Act preclude giving separate data for 1968 and earlier years.
