LEAKING OF CABINET DOCUMENTS—DATE OF REPORT ON INVESTIGATION—POSSIBLE PROSECUTIONS

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I should like to address a question to the Prime Minister. In view of the continuing interest in the subject of [Mr. Olson.]

cabinet leaks, I would ask whether investigations are still being pursued, whether the RCMP are involved, and whether he has given any indication of a date by which he would like a report in this connection?

Right Hon. P. E. Trudeau (Prime Minister): The matter is still being looked into. There is no indication of any time at which any report might be made.

Mr. Alexander: In light of the fact that the investigation will more than likely point the finger at some person or persons, is it the intention of the government and the Prime Minister to lay charges against such person or persons who may be responsible for the leaks?

Mr. Speaker: Order, please. The hon. member will appreciate that the question is hypothetical at this stage.

Mr. Alexander: On a point of order, Mr. Speaker, may I take the opportunity to rephrase the question? Is it the policy of the government—

LEAKING OF CABINET DOCUMENTS—POLICY OF GOVERNMENT IN DEALING WITH OFFENDERS

Mr. Lincoln M. Alexander (Hamilton West): Supplementary to my last question, which was perhaps somewhat ill-phrased, I should like to ask the right hon. gentleman whether it is the policy of the government to lay charges against those who are responsible for leaks regardless of who he or she might be?

Right Hon. P. E. Trudeau (Prime Minister): I can hardly state the government's policy on this complex matter in answer to a question. As the hon. member knows, it is unlikely we would deal with a leak from a cabinet minister in the same way as we might in the case of somebody else, and it is unlikely we would deal with it in the same way if it were a member of the public who was infringing the Official Secrets Act. In other words, there are various ways of getting at someone who is responsible for a leak and I do not know in advance, without being specific on hypothetical cases, how I could say we would act.
