for External Affairs. Can the hon. gentleman say whether the fake passport apparently used by Geoffroy was called for or whether it was mailed and, if it was called for, whether any identification was asked of the person picking up the document?

Hon. Mitchell Sharp (Secretary of State for External Affairs): The application was mailed and the passport itself was mailed to the address on the application form. It was obviously not picked up by Mr. Geoffroy.

An hon. Member: Are you sure?

- Mr. Sharp: I would have to make inquiries to find out who did pick it up. I shall endeavour to obtain the information for the hon. gentleman.
- Mr. McCleave: A further supplementary to the Secretary of State for External Affairs. Can he tell us whether his department was asked to deal with visa applications by anyone using the fake passport in Geoffroy's case?
- Mr. Sharp: Visas are not issued by the Canadian government except, of course, for entry into Canada, and obviously they did not want to move in this direction.
