ployment Insurance Commission which may see to it that such discrepancies do not exist in the future.

In the meantime I can tell the Hon. Member that we are taking two steps. One is to ensure that the provinces concerned offer social security payments to Mr. Hawkins during the time he is in hospital. The second is to ensure Mr. Hawkins that, on his return to Newfoundland, he will be guaranteed work under the Canadians Jobs Strategy.

Some Hon. Members: Hear, hear!

Mr. George Baker (Gander-Twillingate): Mr. Speaker, it is difficult to figure out what is going on here. If a man rushed into a burning building to save a child, he would receive the Governor General's Medal for bravery. This man does not want a medal. ELIMINATION OF FOOTWEAR IMPORT QUOTAS

Mr. Dan Heap (Spadina): Mr. Speaker, my question is directed to the Prime Minister. Doe she remember the promise he made in Sherbrooke on May 4, 1984, when he was campaigning for election in which he said that a Conservative Government would not abolish the import quotas in the footwear and textile industries? Now that the Minister of International Trade has announced that the great majority of the affected quotas will be abolished, will the Prime Minister tell us why he has failed to keep the promise that he made when he was looking for the votes of the workers in the footwear industry?

Hon. James Kelleher (Minister for International Trade): Mr. Speaker, as I have previously advised the House, there were no broken promises. We are not a Party of broken promises.

Some Hon. Members: Oh, oh!

Mr. Kelleher: Where and when quotas are required for the protection of the industry, we will keep them in place. That is exactly what we did. The tribunal said that they were required for children's and women's footwear and we kept them in place.
