POSSIBILITY OF ESTABLISHING BROILER MARKETING BOARD—GOVERNMENT POSITION

Mr. Roch La Salle (Joliette): Mr. Speaker, my question is for the Minister of Consumer and Corporate Affairs.

Since the broiler producers' association has been waiting a long time now for the decision of the cabinet on the creation of a marketing board which would meet the long-term interests of consumers, and since the Minister of Agriculture said he was in favour of such a project, is the Minister of Consumer and Corporate Affairs prepared today to support the Minister of Agriculture, so that the project may be announced as soon as possible?

POSSIBILITY OF IMPLEMENTING RECOMMENDATIONS OF SUBCOMMITTEE—GOVERNMENT POSITION

I ask that because the newspapers spoke of the matter this morning leading to some confusion.

I gave specific instructions that I be given recommendations to that effect, and not I be given the reasons for which recommendations could not be implemented. Instead, I asked them to indicate which recommendations, of which I am sure there will be a number, could be implemented quickly.

SUGGESTION BANKS LOWER INTEREST RATE ON CONSUMER LOANS
