



Police Lay a Plot for Morris Cominsky and It Is Alleged He Fel Into It—Said He Stole \$3,000 Worth of Goods

London, Feb. 22.—James E. Stein, superintendent of the Thiel Detective Service, says the World, steered the city police into as pretty a capture in the early hours of this morning as has been pulled off in many a long day, and now Morris Cominsky, alias Miller, alias Lavine, 114 Grange avenue, is in custody, charged with breaking into the store of Brodey, Draimin & Co., 256 Yonge street, at 11 o'clock last night and stealing about \$3,000 worth of furs. The whole thing was a plan from start to finish, and two of the Thiel detectives operated with Cominsky as accomplices up till the time that the city detectives, who were planted all about, pounced upon their prey and got him with the furs, in a shed at the back, ready to be transferred to a cutter which was to be used to drive them away.


