

127. Resolved, That a sum not exceeding Twenty-eight thousand nine hundred and sixteendollars and eleven cents be granted to His Majesty, for Administration of Justice— Further amount required for miscellaneous justice, including North-west Territories, \$20,000 ; To be paid to the Government of the North-west Territories, on account of remuneration and expenses of stenographers provided by that government for the Supreme Court of the Territories, \$3,000 ; To supplement the retiring allowance of Mr. Justice Henry, (revote of lapsed amount,) \$816.11 ; Further amount required for court room and offices at Prince Albert, \$300 ; To provide salary for a County Court judge for Atlin District, British Columbia, \$2,400 ; To provide salary for a County Court judge for Victoria County, British Columbia, \$2,400, for the year ending 30th June, 1905.

128. Resolved, That a sum not exceeding One thousand two hundred and fifty dollars be granted to His Majesty, for Supreme Court of Canada—To provide for the salary of E. R. A. Taschereau, for the year ending 30th June, 1905.

129. Resolved, That a sum not exceeding Fifteen thousand dollars be granted to His Majesty, for Colonization roads, in the North-west Territories, for the year ending 30th June, 1905.

130. Resolved, That a sum not exceeding One hundred and six thousand three hundred and forty-eight dollars and twenty-three cents be granted to His Majesty, to cover unprovided items, 1902-3, as per Auditor General's Report, Page C-4, for the year ending 30th June, 1904.

The said Resolutions, being read a second time, were agreed to.

Mr. Speaker acquainted the House, That a Message had been brought from the Senate by their Clerk, as followeth :—

The Senate have passed the following Bills without any amendment :—

Bill intituled : " An Act authorizing the Government of Canada to purchase the "Canada Eastern Railway and to take possession of the Fredericton and St. Mary's "Railway Bridge."

Bill intituled : " An Act to amend the Customs Tariff, 1897."

Mr. Speaker presented, a Report of the Commissioners of the Internal Economy of the House of Commons, which is as followeth :—

Report of the Commissioners of Internal Economy of the House of Commons of Resolutions adopted on 28th April, A.D., 1904 :

1. Resolved, That the present classification of the various branches of the Service of the House of Commons, as stated in the Civil Service List, 1904, with verbal changes only (being substantially the same as adopted by the Commissioners of Internal Economy in the year 1885), be retained and confirmed ; and also, that the said several branches and official designations of officials of the House be as specified in Schedule "A" following.

2. Resolved, (a.) That the duties of the several officers and clerks shall be the same as hitherto discharged by those officers.

(b.) That one of the clerks in the Law Branch be designated Secretary to the Law Branch, to perform, in addition to his other work, such duties as may be directed by the Law Clerk.

(c.) That one of the Assistant Translators in the Translation Branch be designated Secretary to the Translation Branch, to discharge such duties in addition to his work of translation, as may be directed by the Chief Translator.

3. Resolved, (a.) That the grades and salaries of the present staff shall be as set forth in the amended Schedule "B", the same being substantially those in accordance with the grades and salaries specified under the Civil Service Amendment Act, 1903.

(b.) That the grades, duties, and minimum and maximum salaries of future appointees shall be those set forth in the said Schedule "B."

(c.) That the office of Assistant English Translator in the Law Branch, at present held by Mr. H. H. Loucks, be, on his retirement, abolished.
