MOTIONS FOR PAPERS

CORRESPONDENCE WITH EXECUTIVE OF
YUKON LIBERAL ASSOCIATION

Question No. 1,572—Mr. Nielsen:

1. With respect to the Post Office Department in the Yukon, since April 8, 1963, who is the postmaster or postmistress at each of the following postal stations in the Yukon: Carmacks, Old Crow, Upper Liard, Haines Junction, Swift River, McCabe Creek, Pelly crossing, Beaver Creek, Destruction Bay, Glacier Creek, Dawson City, Whitehorse R.C.A.F. Station, Whitehorse, Brooks Brook, Ross River, Calumet, Granville, Keno, Elsa, Mayo, Watson Lake, Carcross?

2. Has there been a change of postmaster or postmistress at any of the foregoing postal stations since April 8, 1963, and, if so (a) for what reason (b) what is the name of each postmaster or postmistress in the case of each such change?

3. What contracts for the carriage of mail by air, ground or any other means of transportation are held by any person, firm or corporation within or without the Yukon for mails carried into, out of, or within the Yukon?

4. In the case of each such contract (a) what is the amount (b) what is the name of the holder (c) has there been any change in the terms or provisions thereof or the parties thereto, since April 8, 1963 (d) what is the expiry date?

5. Is it the policy of the Post Office Department to continue calling for public tenders for any and/or all contracts for the carriage of mail into, out of, or within the Yukon, as the policy has been in the six years prior to April 8, 1963?

6. Has the Postmaster General or any official or employee of the Post Office Department had any correspondence with Mr. N. V. K. Wylie, Harry Johannes, Dave Howard, or any other person in the Yukon not in the employment of the government and, if so, what has been the nature of such correspondence?

YUKON TERRITORY—COMMERCIAL FISHING

Question No. 1,573—Mr. Nielsen:

1. With respect to the operation of the Department of Fisheries in the Yukon Territory, to what extent has commercial fishing been carried out in the Yukon since the establishment of the policy allowing commercial fishing in the lakes of the Yukon?

2. Does the government contemplate extending its commercial fishing policy in the Yukon so as to allow fishing to a greater extent in a larger number of lakes than heretofore?

3. What lakes were fished commercially in the Yukon during the years 1962 and 1963, and what number and type of fish were caught in each lake?

4. Were any fish exported for sale outside the Yukon in the years 1962 and 1963 and, if so, what number and type of fish were so exported?

5. Has the government been co-ordinating between the Department of Fisheries and the Department of Citizenship and Immigration (Indian affairs branch) to establish Yukon fisheries for the Yukon Indian people and, if so, what are the details of any plans existent or contemplated for the establishment of such fisheries?

6. What fisheries personnel are now established in the Yukon, and what are the respective salaries?

7. When was the last raise in pay provided to these personnel, and if no such raise has been provided, for what reason?

Mr. Nielsen: Mr. Speaker, I did not hear any reservation expressed by the minister. He said that the correspondence would be tabled.

Mr. Speaker: Would the Postmaster General indicate whether it is with reservation or without reservation?

Mr. Denis: I did not hear the hon. member's question.

Mr. Nielsen: I understood the minister to say the correspondence called for in the motion would be tabled.

An hon. Member: Show a little more "Enterprize".

Mr. Denis: All official correspondence shall be tabled.

Mr. Nielsen: I wonder if the Postmaster General will explain what he means by "official".
