GEOGRAPHICAL CO-ORDINATES RESPECTING BASE LINESMotion No. 201—**Mr. Barnett:**

That an humble address be presented to His Excellency praying that he will cause to be laid before this house a copy of all notes and other communications exchanged between Canada and the United States of America since the enactment by parliament on July 16, 1964, of the Territorial Sea and Fishing Zones Act having to do with the issuance by the governor in council of one or more lists of geographical co-ordinates of points from which base lines may be determined in accordance with the provisions of the act.

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, the documents which have been exchanged between the two governments are privileged, of course. It would certainly not be in the interests of the negotiations that are under way now between governments are privileged, or course. If the United States, Canada and other countries if there were a disclosure of these communications asked. Therefore I must ask my hon. friend on that account to either withdraw his motion or to consent to it being put over until the opportunity arises for both of us to discuss the matter.

Mr. T. S. Barnett (Comox-Alberni): Mr. Speaker, I am very glad at least to discover from the minister that there are some documents on the subject matter of this motion. While we may have an argument on the advisability of tabling them at this time I do believe it might be advisable, in view of the circumstances, that we transfer this motion for discussion.

Mr. Martin (Essex East): No, Mr. Speaker, I do not think this is the way to deal with a matter which obviously concerns privileged documents which, as the house has repeatedly said, should not be tabled, particularly when it is pointed out that important negotiations on that subject are under way.
