CANADIAN CONSTITUTION

CONFERENCE DATES, RELEASING OF DOCUMENTS, FACILITIES

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I should like to inform the House that general agreement has been reached with the provinces that the third session of the Constitutional Conference will be held in Ottawa on December 8, 9 and 10 in the new facilities being prepared in the Centennial Centre. With the agreement of the provincial premiers, I hope to be able to table the agenda early next week, Mr. Speaker.

I might add that the federal and provincial governments have agreed that documents which they will be preparing for the conference will be released in advance of the conference next Thursday at two o'clock in the afternoon, or as soon thereafter as the provinces wish to do so. The federal government will be publishing a paper entitled "Income Security and Social Services". The Federal and provincial governments have also agreed that the meetings will be public and televised.

HEALTH AND WELFARE

MEDICARE—SHARING OF COST OF PUBLIC SERVANTS' PREMIUMS

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, the government has agreed that it will, as an employer, share in the cost of employees' medicare premiums, as recommended by the National Joint Council.

The policy provides that the employer will share in the direct premium charges levied upon employees by provincial governments with regard to medical care insurance. The share of the government will be the lesser of:

(a) 50 per cent of the direct premium, or

(b) \$1.34 for single persons, \$3.38 for married employees and \$4.87 for employees with families.

The specific amounts referred to represent the differences between the basic employer premiums under the Group Surgical-Medical Insurance Plan and the sum of the employer premiums for supplementary medical and hospital benefits available to employees under the Group Surgical-Medical Insurance Plan.
