SPEECH FROM THE THRONE

RESUMPTION OF DEBATE ON ADDRESS IN REPLY

The House resumed consideration of the motion of Mr. Ken James for an Address to Her Excellency the Governor General in reply to her Speech at the opening of the session.

Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, first of all, I would like to congratulate you on your election to the office of Speaker of this House. Since this is my return to the House of Commons after four years of toiling in the field of Nickel Belt, I feel I should thank all the workers on this Hill, such as the messengers, the bus drivers and all of those who responded to my return with a very warm welcome. I would also like to thank Hon. Members on both sides of the House who have so warmly welcomed me as a representative of the people of Nickel Belt. I must not forget the people of Nickel Belt who saw fit to return me to the House of Commons as their Member of Parliament. I say to them that I will do as I pledged on election night. I will work as hard as I possibly can to represent them in a fair, just and open manner.

In the four years I spent in the field in Nickel Belt, I had the opportunity to be associated with young people in my profession of teaching. It was very important to me because I had the opportunity to really see from the grass roots how young people view politics and politicians and how they view the House of Commons. I felt moved to speak in this debate because it is seldom we have an election, followed by a Throne Speech, followed by a mini-budget. When one event is superimposed on another, one gets a picture. Something which struck me about this whole process over the last three weeks is that the election campaign, the Throne Speech and what
