This is the worst tax at the worst time. This government knows it. Experts know it. Canadians know it. Will the Deputy Prime Minister now bring in a fair tax

system and withdraw the GST today?

Hon. Gilles Loiselle (President of the Treasury Board and Minister of State (Finance)): Mr. Speaker, I am amazed: 48 countries, among which are the most modern countries in the world, have such a tax.

I know that the opposition parties have had a fixation. They know that taxes are unpopular. They have been attacking this tax with great vigour, but they have been carried away by their own speeches. I am not.

This is a modern reform. It has been called for for 50 years. Committee after committee has recommended it. We are doing it. It is a tough thing. In so doing we are also listening to people and, when we can bring in improvements, we are doing it.

Ms. Audrey McLaughlin (Yukon): This government keeps saying, Mr. Speaker, that it is doing a tough thing. What Canadians wish is that it would do the right thing.

Mr. Speaker, the battle opposing the Liberals and the Conservatives in the Senate goes on. This government will just not give up. While the battle goes on, the victims are forgotten. And who are those victims? They are, Mr. Speaker, the million and some unemployed men and women in Canada as well as the small businesses that can no longer manage to survive.

It is time this government recognized it made a mistake. It is time for them to swallow their pride. I ask the Deputy Prime Minister: Will the Prime Minister finally swallow his pride and withdraw the GST as common sense would dictate?

Hon. Gilles Loiselle (President of the Treasury Board and Minister of State (Finance)): Mr. Speaker, I can only repeat to the hon. Leader of the New Democratic Party that we will do no such thing because, she can say what she pleases, the GST is an excellent tax and a fair tax. Of all comparable systems, it is the fairest because of the tax credits.

That being said, the hon. member requested that we change our policy. To that I say, as we say in English, the proof is in the pudding. If you look at the interest rates today, you will notice that they are down 15 basis points. They have been going down for several months now. That is our goal and it is achieved through a serious

policy designed to control inflationary pressures. These pressures are decreasing. Like all Canadians, we are delighted. The big winner is not the government but the Canadian people.
