Mr. Jim Edwards (Parliamentary Secretary to Minister of State and Leader of the Government in the House of Commons): Mr. Speaker, would you be so kind as to call Starred Questions Nos. 438 and 443.

*Question No. 438—**Mr. Saint-Julien:**

Concerning the airport industrial parks managed by Transport Canada, (a) how many are there (b) which ones are they (c) have grants been made to these serviced parks in order to make commercial and industrial developments and, if so, (i) how much have these parks received each year since 1980 (ii) how many commercial industries are there in each of these parks and for each industry, and is the building ownership clause included in each lease?

Routine Proceedings

What is the total amount of payments, grants, transfers or any other contribution made by the government and/or the Atlantic Canada Opportunities Agency to Atlantic Turbines or Mr. Craig Dobin since September 17, 1984, and what was the purpose of each payment?

Hon. John C. Crosbie (Minister of Fisheries and Oceans and Minister for the Atlantic Canada Opportunities Agency): Insofar as the Atlantic Canada Opportunities Agency is concerned, see below:

Hon. Jean Corbeil (Minister of Transport): (a) Three.

(b) and (c) (ii) The location and number of industries in airport industrial parks managed by Transport Canada are: Gander International Airport (one lessee with 10 sub lessees), Ottawa International Airport (three lessees) and Regina Airport (one lessee with four sub lessees).

(c) No grant(s) was or are paid.

(i) Not applicable.

(ii) Transport Canada does not have a building ownership clause. However, if the member is referring to the occurrence of vesting the end of a lease, there is a form of vesting clause in most of the leases with Transport Canada which expresses the action of common law on leasehold improvements at lease termination.

*Question No. 443—**Mr. Duhamel:**

Since September 1984, (a) how many post offices have been closed and what were their locations and (b) how many post offices or postal facilities have had their range of services reduced and what were their locations?

Hon. Harvie Andre (Minister of State and Leader of the Government in the House of Commons): (a) From a rural perspective, the only recent change to postal
