And Whereas, the adoption of trade barriers and restrictions by many nations coupled with the very limited amount of gold available in the world for the interchange of goods and services has in large measure contributed to, if not brought about the unemployment of millions of people with its consequent untold misery and suffering;

And Whereas, due to economic and existing monetary conditions many thousands of Canadian citizens have had to be sustained or given employment by the state;

And Whereas, Canada has been borrowing large sums to provide for the relief of the unemployed and destitute;

And Whereas, the issuing of currency in Canada has been based on certain coverage of gold, thereby restricting the amount of currency issued;

Therefore be it Resolved,—That, in the opinion of this House, the Government take immediate steps to adopt silver in addition to that of gold for the issuance of currency either in the form of paper certificates or as coinage, and that silver be again recognized and accepted as legal tender by the Dominion of Canada at a fixed ratio to that of gold.

Mr. Neill—On Monday next—The following proposed Resolution:—That, in the opinion of this House, the most effective way to ensure protection during periods of unemployment, which unemployment insurance should provide, is to make such legislation national in its scope.

Mr. Duff—On Monday next—The following proposed Resolution:—That, in the opinion of this House, it is expedient that the Government of Canada reopen negotiations with the government of the United States of America with a view of bringing about a satisfactory reciprocal trade arrangement between Canada and the United States, whereby the natural products of Canada, that is, the products of the sea, the farm, the mines and the forests, and including fish, lumber, wheat, cattle, etc., should have free entry into the United States in exchange for the admission of certain goods from the United States of America, which in the interests of both countries may be admitted into Canada, free from customs tariffs.

Mr. McKenzie—On Monday next—The following proposed Resolution:— That, in the opinion of this House, an immediate inquiry should be made under the provisions of the Research Council Act, Chapter 177, R.S.C. 1927, or by other means, into the causes underlying the wide spread between the prices of raw products and the prices of goods manufactured from such products.

Mr. Dickie—On Monday next—The following proposed Resolution:—That, in the opinion of this House, a national flag representing the Dominion of Canada should be adopted.

Mr. McGibbon.—On Monday next—The following proposed Resolution:— That, in the opinion of this House, it is expedient, in view of the large amounts of money invested by the Dominion in canals and railroads, that all goods shipped through the canals owned and operated by the Government of Canada be subject to taxation.

Mr. Lucas—On Monday next—The following proposed Resolution:— Whereas, the provision of an adequate medium of exchange through the issue and control of currency, is a function inherent in the State, and one which is wholly within the jurisdiction of the Federal Parliament, and
