SAYS JOHN WILKES BOOTH ESCAPED

Fled to Mexico, and Died by His Own Hand in 1903 in Oklahoma.

DETROIT, June 29.—Philo L. Bates, of Memphis, attorney, has published a book entitled "The Escape and Suicide of John Wilkes Booth." Mr. Bates claims to have positive proof that Booth, the assassin of President Lincoln, not only escaped after killing the President in Washington in April, 1865, but lived until 1903, committing suicide in Oklahoma.

The author further alleges that Booth made a confession to him some eight years ago in which he implicated Andrew Johnson, Vice-President of the United States, as being an accomplice in the murder.

Here is the main part of the confession as related by Bates in his book: "It had never entered my head to kill President Lincoln until the afternoon of the day I committed the deed. I and others had tried for a year and a half to kidnap Lincoln and take him to Richmond as a hostage of war. We came to Washington that day to make a final effort, but when we arrived in the city we learned for the first time that Gen. Lee had surrendered.

EGG-SHAPED BOAT THAT CANNOT SINK

Unique Invention of Young Norwegian.

Proves Successful—The French Govern- ment Will Make an In- vestigation.

LONDON, June 29.—A peculiar egg-shaped craft, resembling somewhat a submarine vessel, and flying the Nor- wegian flag, was the centre of attraction yesterday along the Thames, when she was slowly towed from London docks to Westminster Bridge, and moored outside St. Thomas' Hospital.

The strange vessel is the invention of Captain Brude, a young Norwegian, who claims to have solved the problem of constructing a life-saving boat for passenger and cargo vessels, capable of resisting rough seas, solid weather and hurricanes with equal ease.
