**Commissioner of Crown Lands' Office,
Toronto, 4th April, 1839.**

IT IS ORDERED, by His Excellency the Lieutenant Governor, in Council, that unless the Claimants, or their Representatives, do assert their respective Claims to the Lots mentioned in the following list, within Twelve Months from this date, the Locations will be forfeited.

It is also Ordered; That the lots of Land contained in the said list be inspected, and, that in all cases of Location upon condition of actual settlement, or performance of settlement duties, Lands located before the first day of January 1832, upon which it shall appear that no actual settlement shall have been made, or no settlement duties performed, (as the case may be,) shall be declared forfeited, upon a return of such inspection.
