The usual Accounts and Estimates shall be laid before you, and I trust you will make the necessary provision for the public service.

Mr. President, and Gentlemen of His Majesty's Council, Mr. Speaker, and Gentlemen of the House of Assembly,

Fully sensible that it is my duty, as it is my inclination, to execute the trust committed to me by my Sovereign, with the utmost advantage to the Province, it has naturally been my endeavour to make myself acquainted with its general interests, and to ascertain how far the measures, recently adopted, by the Legislature, were, on trial, likely to

produce the results for which they were contemplated.

The Fisheries have, under the encouragement you have afforded them, been engaged in with spirit, and, it is hoped, with advantage to the persons most interested in their success; and although I am not yet enabled to give you all the information desirable, in regard to the operation of your Act for promoting the establishment of Schools, it aprears to have been extensively beneficial. A full report on his interesting subject shall be submitted to you, so soon as the Commissioners in the several Counties shall supply the necessary details.

I shall freely communicate with you by Message on all subjects touching the public interests, as occasions may arise, in the fullest assurance, that any suggestion which, by your labours, can be rendered subservient to the increase of the general welfare, will not

be recommended by me to your consideration in vain.

Report of Address in answer to Speech
