# FINANCIAL AID TO NORTH-WEST TERRITORIES.

The MINISTER OF FINANCE (Hon. W. S. Fielding) moved that the House go into committee to-morrow to consider the following proposed resolution:—

That it is expedient to enact as follows :-

- 1. The Governor General may,in his discretion from time to time, advance to the government of the North-west Territories any sum required for local improvements in the North-west Territories, not exceeding in the whole the sum of two hundred and fifty thousand dollars.
- 2. All sums so advanced to the government of the North-west Territories shall be charged in an account to be known as 'The North-west Territories Debt Account,' and shall in any financial arrangement that may be made in connection with the organization of a province
