Questions

It is not in the interests of former employees to make the reason given by each employee for departure publicly known.

## ANIMAL EXPOSURE TO EXPERIMENTAL BLAST, SUFFIELD STATION

# Question No. 1,900—Mr. Howe (Hamilton South):

1. In the t.n.t. blast experiment at the Suffield experimental station in Alberta on July 17, 1964, were animals exposed to the blast by any research team and, if so, for what purpose?

2. What kinds of animals were used and how many of each kind?
3. How were these animals used or disposed of

after the experiment?

Hon. Paul Hellyer (Minister of National Defence): 1. Yes, to take advantage of an opportunity to expose animals, the weights of which bracket the human body weight, in an environment free of nuclear and thermal radiation giving a blast-pulse similar to a kiloton weapon.

2. Twenty sheep, 108 goats and 24 cattle.

3. Observations of effects on the animals were recorded immediately. Any animal with evidence of painful injury was anaesthetized while being examined. Survivors were killed painlessly by intravenous administration of membutal. All animals were also studied by post mortem examination. After post mortem examination the carcasses were buried.

### VISIT OF CANADIAN STUDENTS TO CUBA

#### Question No. 1,901-Mr. Coates:

The issuance of entry visas if required for the admission of Canadians to another country is the responsibility of the authorities of the country to be visited.

accommodation for the students.
