THREATENED STRIKE OF TORONTO PRODUCERS

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, having regard to the fact that apparently negotiations or discussions between the producers and the C.B.C. president and management have broken down, and the fact that there has been a virtual ultimatum that on Sunday at 10 p.m., unless the request of the producers has been met, there may well be a strike, I should like to ask the Prime Minister what action the government intends to take to bring about the assurance that these negotiations will continue? What representations, if any, again consistent with the legislation setting up the C.B.C., has the government made? The Prime Minister said yesterday that he was very anxious and willing to use his good offices in this.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, paraphrasing the reply to this question yesterday, I think I said that naturally the government was anxious to do what it could to help in this regard, subject to the desirability of not intervening in the affairs of the C.B.C. My right hon. friend will know the difficulty in respect of government action in a matter of this kind, as it relates to a crown corporation.

I understand, Mr. Speaker, that a committee of the house is considering this matter today. It has before it a resolution on the very point my right hon. friend referred to, and I should like to wait to see what the committee does with that resolution this afternoon before I say anything more.

Mr. Diefenbaker: A supplementary question, Mr. Speaker. Can the Prime Minister say what that resolution is to which he made reference?

Mr. Pearson: I think the resolution deals with the possibility of the government's intervening, in order to bring about a solution of this difficulty.

## PRIVILEGE

MR. LAMBERT-INABILITY TO OBTAIN ELECTORAL COMMISSION REPORTS
