We were here and we heard witnesses. Through no fault of mine, we are still hearing witnesses. If the minister wanted to rush the bill through and only hear one or two witnesses, that was his prerogative. I know for a fact that copies of the bill were not available all summer long. I accuse the minister of deliberately keeping the public from knowing the full import of this bill, and I accuse the minister as well-

Mr. Speaker: Order, please. Obviously we are getting involved in a debate on this bill, and I would suggest that this debate continue whenever we reach this order of business. I recognize fully that perhaps the first question should not have been allowed. I continue to recognize the import of the question and the bill referred to in it, but the hon. member has stated his question of privilege.

Mr. Horner: The minister should withdraw.

Mr. Speaker: Order, please. The hon. member has placed an interpretation on the words of the minister. Perhaps the minister might want to make an explanation in one word, because we ought to get back to the question period.

Mr. Horner: I would like to finish my question of privilege.
