**IDENTIFICATION OF CRIMINALS ACT**

**PROVISION FOR DESTROYING OF RESULTS OF  
 IDENTIFICATION PROCESS UPON DISCHARGE OR  
 ACQUITTAL OF ACCUSED**

**Mr. J.-J. Blais (Nipissing)** moved for leave to introduce Bill C-237, to amend the Identification of Criminals Act.

**Some hon. Members:** Explain.

**Mr. Blais:** Mr. Speaker, the purpose of this bill is to amend the Identification of Criminals Act to provide that the results of the identification process be destroyed upon the discharge or acquittal of the accused. As the statute presently stands, the results of the identification can become part of police records and can be used by the constabulary as they see fit and published and distributed generally among the police forces throughout Canada.

The amendment is to bring the statute into line with the time-honoured tradition of the Canadian criminal process that a person is not deemed to be guilty until proven guilty.

Motion agreed to, bill read the first time and ordered to be printed.
