REQUEST FOR TABLING OF DOCUMENTS

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, during an exchange in Question Period the Minister of Finance referred on a number of occasions to a number of reports and studies that his Department has completed. I wonder if the Minister would do the time honoured and traditional thing and table those reports in the House so that all Members will have the opportunity to evaluate that information.

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, I would refer the Hon. Member to *The Goods and Services Tax* brochure dated April 27. A number of elements in it relate to the economic cost of the federal sales tax on page four and on subsequent pages, as well as on the competitiveness and growth impacts which are on pages 15 to 18. I would also remind the Hon. Member that there will be a technical paper which I will be making available hopefully later this month. In that paper there will be further information on the economic impacts.

Mr. Riis: Mr. Speaker, I appreciate the Minister of Finance sharing with us some of the comments in the *Budget Papers* which we have all read and studied. However, he made reference to a number of other documents, particularly economic impact studies that his Department had completed. They were the ones to which I was referring.
