THE AUTOCAR MAKES A RECORD.

Hail to the autocar! In a race that came off in France on Wednesday, the distance between Bordeaux and Paris, 333 miles, was covered by a self-propelled vehicle in less than 12 hours. This is the exact distance between Toronto and Montreal. Fifteen years ago it used to take longer than this for the Grand Trunk express trains to go from the one city to the other. The French mode of rapid travel has made an average of twenty-eight miles an hour for the whole distance. There must be something inherently valuable in a device which can accomplish such wonderful results. The autocar promises to change the entire aspect of the traffic of the future. It is long to witness a great transformation in our method of moving freight and conveying passengers.
