DIVORCE LAW REFORM

Equality in Moral Standard for Both Sexes Sought.

London, March 1.—The equal moral standing of the wife with the husband in the matter of a suit for divorce is the chief question involved in the matrimonial causes bill now before the House of Commons.

The measure provides that a wife is entitled to a divorce on the ground of adultery alone, whereas at present she must prove desertion or cruelty in order to obtain a divorce, although under the existing law the husband may receive his freedom solely because of his wife's adultery.

The divorce reformers urge that this constitutes an unfair differentiation in the standard of morality that is ex-

But there is no valid reason why the suggested favor should be granted in this instance. Nova Scotia, Prince Edward Island and New Brunswick hold in their own hands the logical and just means of defence against a gradual deterioration of their parliamentary influence. They have only to maintain a growth in proportion to that of the Province of Quebec. It would be a contradiction of the principle of democracy to fix an irreducible minimum of parliamentary representation."
