PRAYERS.

The following Petition was brought up and laid on the Table :

By the Honorable Mr. *Leonard*; of the *London* Board of Trade.

Pursuant to the Order of the Day, the following Petition was read :

Of *James Swift* and others, of the City of *Kingston*; praying for the extension to the Dominion of such provisions of the Merchant Shipping Acts of 1854, 1855 and 1862, as may appear practicable, and further for the establishment of some system whereby provision may be made for sick and disabled seamen, and the support of their widows and orphans.

The Select Committee appointed to examine and report upon the Contingent Accounts of the Senate for the present Session, beg leave to make a second Report.

Your Committee have examined the accounts of the Clerk of Your Honorable House from the first day of July, 1867, to the thirty-first day of May, 1869, and have compared the vouchers with the accounts, and find they agree.

Your Committee find the balance in the hands of the Clerk at the last mentioned date to have been sixty-one thousand eight hundred and fifty-four dollars and forty-five cents. (\$61,854.45.)
