- Assessments.** Bill to regulate assessments in the Province, 945, 947, 962.
- Bill to authorize the Justices of the County of Charlotte to assess the inhabitants of the County for erecting a gaol, 948, 956, 959, 980. *Passed.*
- Bill to authorize the Justices of the County of York to levy an assessment for the purpose of paying off the debt due on the County Court House, 954, 958, 967, 980. *Passed.*

- Aymar, John.** Bill to grant him the privilege of supplying the town of Saint Andrews with water by pipes, 949, 951, 957, 960, 963, 980. *Passed.*

- Bread.** Bill to continue the Act of 5 G. 4, c. 18, for regulating the assize of bread in Fredericton, 939, *ib.* 941, 943, 979. *Passed.*
- Bill to regulate the assize of bread in the Parish of Portland, 939, 941, 943, 979. *Passed.*
- Carmen.** Bill to authorize the justices of the Peace in the several counties to make regulations for carmen, waggoners and truckmen, and the measurement of coal and salt, 945, 947, 948, 980. *Passed.*
- Cattle.** Bill for the more summary punishment of persons guilty of maliciously killing, maiming, disfiguring or otherwise injuring cattle, 939, 941, 945, 947, 956, 961, 962, 966, 980. *Passed.*
- Church lands.** Bill to authorize the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Kingston, to make certain conveyances of land now held by them in trust, in exchange for other lands, 943, 946, 956, 959.
