C.A.R.U., having been duly sworn states:

"I produce:

- (a) CERTIFIED TRUE COPY OF COURT OF INQUIRY, purporting to be signed by Major H.C. Edworthy, Administrative Officer No 2 C.A.R.U., officer having custody of original document, relating to the accused whom I now recognize.

a soldier of the Cdn Army Overseas, having been duly sworn,  
states:

"On the 6 Apr 44 I examined the Kit of A 54697 Gunner Johnson J.M., whom I now recognize and found him to be deficient of equipment, clothing and regimental necessaries to the value of Three Pounds, Six Shillings and Six Pence (£3:6:6), which sum is 75% of the vocabulary price of such articles which amounted to Four Pounds, Nine Shillings and One Penny (£4:9:1), in accordance with C.A.(O)R.O. 1398 as per list I am now presenting."

This list is marked Appendix "D" and annexed to the Summary of Evidence.

The accused declines to cross-examine this witness.

The accused was cautioned as follows: "do you wish to make any statement or to give evidence on oath? You are not obliged to say anything or give evidence, unless you wish to do so, but whatever you say or any evidence you give, will be taken down in writing and may be given in evidence."

The accused declines to make a statement and reserves his defence.
