Ald. Taylor, in the absence of the chairman of the works committee, explained that the engineer disapproved of the construction of brick sewers in winter but had no objection to tile sewers. It was only drains of the latter kind that

Ald. Blevins called attention to market. Ald. To obviate this, he proposed that the city should pay one half the cost of the construction of the roadways and the owners of the property on each side of the street the other half.

Ald. Boswell spoke strongly in favor of the frontage tax system as the only means of securing good streets.
