TRANSFER OF LONG BRANCH, ONT., RIFLE RANGE TO WOODBRIDGE IN YORK COUNTY

On the orders of the day:

Mr. Gordon Graydon (Peel): I should like to direct a question to the Minister of National Defence, arising out of an announcement made yesterday by the Minister of Planning and Development for Ontario, in which he indicated that the Long Branch rifle ranges had been acquired by Central Mortgage and Housing Corporation, and that plans were under way to provide some 2,000 housing units in that area.

Mr. Speaker: Order. I suggest to the hon. member that he should ask his question directly.

Mr. Graydon: I shall do so. When does the department expect that the rifle ranges will be vacated by the military, and in what part of the county of York near Woodbridge is the new rifle range to be located?

Hon. Brooke Claxton (Minister of National Defence): Mr. Speaker, as the hon. member for Peel said, this arrangement was announced simultaneously yesterday by the minister in Ontario and by myself. The time at which the change-over will be made from the existing range at Long Branch to the proposed range at Woodbridge will depend upon the time at which we can get possession of the 1,800 acres at Woodbridge, and construct on it the necessary butts, ranges, accommodation, and so on.
