- 2. The actual costs are not known to C.M.H.C. However, the aggregate of the estimates of costs, including land, provided by the borrowers at the time the loans were applied for, is \$23,116,870.
- 3. C.M.H.C. is unable to make such an estimate.
- 4. Atomic Energy of Canada Limited expects to have a requirement for 100 dwelling units by 1964 at the residential area to be associated with its Whiteshell nuclear research establishment in Manitoba.
- 5. It is planned that the residential area will be a local government district of the province of Manitoba so that private builders will be able to build houses in this community. Hence, there is no way of knowing how many of these dwelling units will be built with the aid of C.M.H.C. funds.
