Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, a number of steps have been taken, far more than you will permit me to list in reply at this time. I am sure the hon. member will find on examination that many returns to the Ontario producers have increased rather substantially in the last four to five months.

BARLEY—SUGGESTED INCREASE IN INITIAL PRICE TO PROVIDE GREATER INCENTIVE TO PLANT

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I have a question for the minister responsible for the Wheat Board. Will any further action be taken as a result of the meeting he had with some provincial ministers of agriculture regarding the possibility of increasing the initial price of barley, a suggestion I made to the minister earlier, in the hope that farmers will increase their acreage this year?

Hon. Otto E. Lang (Minister of Justice): In the discussions I had recently with the provincial ministers of agriculture we reviewed the same factors which had existed and which we had reviewed prior to the March 1 announcement of initial prices. At that time I had discussions with the Wheat Board and with many producer organizations concerning the proper level for initial prices, and the agreed 5 cent increase for barley was determined at that time. I see no reason to change it now. All of us are agreed that it is desirable for farmers to increase their barley plantings slightly over what was shown by the Statistics Canada survey.

REGIONAL ECONOMIC EXPANSION

REQUEST FOR INTERIM REPORT ON CERTAIN GRANTS

Mr. John Burton (Regina East): Mr. Speaker, I wish to ask the Minister of Regional Economic Expansion a question, if he will take his mind off election planning for a few minutes. Can he indicate when he will be able to fulfil his obligation under the law and present to the House a supplementary report on the Regional Development Incentives Act, which he promised to present as soon as possible? Can he tell us how soon "as soon as possible" is?

Mr. Burton: Has the minister given any further consideration over the weekend to the production of an interim report such as was suggested earlier?
