lish an agreed amount of their normal benefit payment which will be applied against any non-fraud overpayment. This agreed deduction has always been part of UIC procedure for non-active claims but was not applied to active claims. This new policy ensures that prior to any recoupment of overpayments from benefit, the claimant will be contacted and will be given the opportunity to agree to a deduction which must be in the range of 25% to 75% of his weekly unemployment insurance rate. At present, this policy is being carried out by contacting the claimant prior to setting up any overpayment on the computer system.

3. Implementation of Type 3 monitored payments is now taking place. The tentative implementation schedule is: Quebec Region, August 14, 1973; Ontario Region, September 10, 1973; Prairie, September 17, 1973; Pacific, September 24, 1973; Atlantic, October 1, 1973. These dates are dependent on scheduled delivery of equipment. On August 15, 1973, the computer system will automatically delay recoupment by three weeks on non-fraud overpayments in order to allow time to contact the claimant and agree on a deduction.
