Oral Questions

POSSIBLE ESTABLISHMENT OF GUARANTEED ANNUAL INCOME PLAN—PROGRESS OF NEGOTIATIONS WITH PROVINCES

Mr. Louis Duclos (Montmorency): Mr. Speaker, my question is directed to the Minister of National Health and Welfare.

Could the minister tell the House when the government will be in a position to implement a guaranteed annual income policy giving an appropriate income to the Canadian people who have to leave the labour market before being eligible for old age pension, and could he make a progress report on the negotiations with the provinces on this subject?

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, the negotiations with the provinces ended in June last year and all provinces expressed support for the income supplement program; Ontario is the only province to reject this proposal; the other provinces endorsed the proposal either in principle or categorically.

However, a lot of work still has to be done regarding the precise administration of such a program. I am still waiting for some answers on the part of the provinces to consider the number of steps they want to take in the implementation of this kind of program if it were managed by provincial authorities. The proposal we have brought forward implies a provincial administration with a cost-sharing of 50 per cent of the expenses by the federal government. If we cannot reach sufficient agreement with the provinces, we shall have to consider other alternatives.

MEASURES TO IMPROVE CLIMATE FOR BUSINESS— GOVERNMENT ACTION

Mr. Gordon Towers (Red Deer): Mr. Speaker, my question is for the Minister of Finance. In view of the statement of the chairman of Canada's larges telecommunication equipment manufacturers, Northern Telecom Limited, that his company may shift a major portion of its operation to the United States unless the business climate in Canada improves, I ask, what action does the government contemplate to make sure that the climate for business in Canada improves, so that business and manufacturers in Canada may feel secure?

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, to refer particularly to Mr. Scrivener's remarks, he laid emphasis on the comparative wage rates in Canada and the United States, attesting the acceleration which has occurred in Canada in recent years. As the hon. member knows, one of our principal concerns in maintaining the anti-inflation program is to reduce the rate of increase of costs in Canada, the very situation which all Canadians, as well as Mr. Scrivener, I am sure, would like to bring about.

Mr. Towers: A supplementary question, Mr. Speaker. Can the minister tell the House if there will be an improvement within the next 12 months?

Mr. Macdonald (Rosedale): Mr. Speaker, everything I can do to bring it about will be done.

REQUEST FOR COMMITTEE STUDY OF PROPOSALS FOR FREEDOM OF INFORMATION LEGISLATION

Mr. G. W. Baldwin (Peace River): Mr. Speaker, my question is directed to the government House leader. The proposals will be sent forward to the committee just as soon as they have received proper scrutiny and we have reached the conclusion that they would satisfy the hon, member.
