- Right Hon. P. E. Trudeau (Prime Minister): 1 and 2. Yes, Chapter 370, Sections. 8.3 and .3.2.2 of the Treasury Board Canada Administrative Policy Manual.
- 3. Yes. There are no amount limits. Officers in such situations, under the terms of the Public Servants Conflict of Interest Guidelines, must ensure that such pecuniary interests do not conflict with the discharge of their official duties and disclose such interests to their superiors if they might be construed as being in actual or potential conflict with their official duties.

MR. MICHAEL PITFIELD

Question No. 2,547-Mr. Cossitt:

- 1. With reference to the answer to question No. 1,217 which stated in part that after his reappointment as Clerk of the Privy Council and Secretary to the Cabinet Mr. Michael Pitfield made regular trips to and from Boston to visit his family and that first class air travel was permitted by the government, is it the policy of the government to provide payment for Mr. Pitfield to visit his family or for other senior public servants to visit relatives who happen to live in a location other than Ottawa and, if so, how is such expenditure of public funds warranted?
- 2. What was the total amount spent by the government on trips to and from Boston made by Mr. Pitfield, including the date and amount in each case?
- 3. Was there an agreement between the government and Harvard University and/or Mr. Pitfield that he should perform certain duties for the university after his reappointment in Ottawa and, if so, what are the details of the agreement and for what reason was it approved?
- Right Hon. P. E. Trudeau (Prime Minister): 1. Answers 1,217 and 1,217 (revised) stated in part that following his reappointment as Clerk of the Privy Council and Secretary to the Cabinet, Mr. Pitfield made regular visits to Boston until the end of the 1979-80 academic year to visit his family and complete his teaching obligations to Harvard University.
- It is the policy of the government when recruiting an individual into the public service to negotiate appropriate transitional arrangements with the individual concerned and, where necessary, with his employer. See also question 2,386, parts 3 and 4, answered May 25, 1981.
- 2. In relation to part 1 above the cost of the following travel between Ottawa and Boston by Mr. Pitfield was paid by the government:

Question No. 3,696—Mr. Crosby:

- 1. What position was held by Mr. Michael Kirby prior to December, 1981 and what remuneration was paid to him?
- 2. Did he receive any benefits other than dollar remuneration and did the benefits include payments or allowances for regular weekly or more frequent trips between Ottawa, Ontario and Halifax, Nova Scotia for personal reasons?
- 3. Was the remuneration paid on the basis of the regular public service workday and work week and, if so, how did he account for any time spent in personal travel between Ottawa and Halifax?
- 4. (a) What is his position at present (b) what is the remuneration and does it include allowances for personal travel?
- Right Hon. P. E. Trudeau (Prime Minister): 1. Secretary to the Cabinet for Federal-Provincial Relations on exchange from the Institute for Research on Public Policy (IRPP). Remuneration—DM-2, \$73,400—\$86,000.
- 2. In addition to dollar remuneration, the exchange agreement with the IRPP provided for the payment of expenses for a weekly trip on the average by air (economy class) for Mr. Kirby to and from Halifax, including expenses for ground transportation.
- 3. The remuneration was paid on the basis of the regular public service work week, although it is recognized that deputy heads work many hours of overtime for which no extra remuneration is paid. Time spent in personal travel did not infringe on official business time.
- 4. (a) Secretary to the Cabinet for Federal-Provincial Relations. The exchange agreement with the Institute for Research on Public Policy was terminated as of December 31, 1981. (b) See 1 and 2 above.
