## ALLOCATION OF FUNDS TO ATHABASCA RIDING

**Mr. Jack Shields (Athabasca):** Madam Speaker, I would like to direct a question to the Minister of Employment and Immigration. The allocation of funds to the Athabasca riding under the Canada Community Development Program is down considerably from last year, and this during a year of high unemployment in the Athabasca area because of the disastrous shutdown of the Alsands and Cold Lake projects. Will the Minister be allocating more funds to the Athabasca riding?

**Hon. Lloyd Axworthy (Minister of Employment and Immigration):** Madam Speaker, as always, I am prepared to look at the allocations on the constituency level. I would remind the Hon. Member that under the \$300 million program that we announced last July, which is just now coming into effect, there is a special allocation called the Special Response Fund which is designed to be allocated to those areas particularly hard-hit by immediate or recent changes in the employment picture. If the Hon. Member would like to prepare a dossier for me concerning the conditions faced by his riding, he knows I would give a sympathetic hearing, as always.

## PROJECTS FOR NATIVE PEOPLE

**Mr. Jack Shields (Athabaska):** Madam Speaker, I would like to direct a supplementary question to the Minister of Employment and Immigration. As the minister is aware, northeastern Alberta contains most of the area covered by Treaty No. 8 and a number of reserves where employment is probably hitting 90 per cent or 95 per cent. Will some of that special allocation fund be made available for employment projects for native people in the Athabasca riding?

**Hon. Lloyd Axworthy (Minister of Employment and Immigration):** Madam Speaker, I have to remind myself exactly of where the money has been allocated in that portion. I would again point out that as part of the community development job creation effort, we do have a special stream for native people, an additional \$10 million which is designated according to where there are large concentrations of reserves or native communities. I am sure that that portion of the money has been allocated in that area, but I will check to make sure that it has been done in an equitable way.
