USE OF EVIDENCE FROM SOVIET UNION BY DESCHÊNES COMMISSION

FULL INDEXATION OF FAMILY ALLOWANCES

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, I have two petitions to present today. The first is from a group of residents of my riding, particularly the Hastings-Sunrise area. They call for reindexation of the family allowance. Its deindexation, combined with tax increases and budget handouts, has placed an extraordinary burden on families, especially on women, single parents and poor families. They call on the House of Commons to reinstate the full indexation of family allowances and rescind unfair tax increases.

The second petition is very interesting because many of the signatures are in Chinese characters. It is from residents of the Strathcona area and downtown east side of Vancouver, and

they call upon the House of Commons to reinstate full indexation of universal family allowances and rescind unfair tax increases.

Mr. Ernie Epp (Thunder Bay-Nipigon): Mr. Speaker, in the middle of National Family Week it is my honour to present a petition from constituents in the City of Thunder Bay who protest deindexation of family allowances and other changes in our family support system. They protest the hand-outs which the Government has proposed and which represent a burden on families. They call upon the House of Commons to reinstate full indexation of universal family allowances and rescind unfair tax increases.

Mr. Rod Murphy (Churchill): Mr. Speaker, I also have a petition signed by Canadians right across this land who would like to add their voice to those calling upon the Government to reinstate full indexation of universal family allowances and rescind the unfair tax increases in the Budget.

TOURIST PUBLICATIONS

Question No. 412-Mr. Robichaud:

- 1. In 1984, how many United States tourist publications were sold in Canada and what income accrued to the government from the 10 per cent tax?
- 2. (a) In 1984, how many Canadian tourist publications were sold or given away (i) in Canada (ii) abroad (b) what income accrued to the government from the 10 per cent tax?

Hon. Ray Hnatyshyn (President of the Privy Council): I am informed by the Departments of National Revenue and Regional Industrial Expansion as follows:

1 and 2. There is no mechanism to record the number of United States tourist publications sold in Canada or of Canadian tourist publications sold or distributed in Canada or abroad.

Revenue Canada advises that its own records do not differentiate between tourism literature and other forms of printed matter. Therefore, the information pertaining to the income from the 10 per cent tax on tourist publications is not available.
