Committee on Privileges and Elections empowered to enquire and report whether the election of the said Thomas McGreevy was being lawfully contested at the time he tendered to Mr. Speaker his resignation as aforesaid, and if such fact is found in the affirmative, whether the Warrant of Mr. Speaker should have issued for the issue of a new Writ, and what practice should be adopted with reference to similar resignations tendered Mr. Speaker in the future by Members of this House, 576.
