Mr. TUCKER: The facts surrounding the purchase of these lands from the official custodian and their resale to veterans are readily available to the public accounts committee, and the Department of Veterans Affairs would welcome the most searching inquiry. Until this has been done I suggest that in fairness to the public servants involved no such charges, impugning the fairness and honesty of those public servants, should have been given such wide publicity.

Some hon. MEMBERS: Order.

Right Hon. IAN A. MACKENZIE (Minister of Veterans Affairs): Seeing that I was personally attacked this morning in the editorial in question in the Toronto Globe and Mail, I think it is my right as a member of this free and unfettered parliament to rise on a question of privilege. I intend, sir, to ask the standing committee on public accounts which is now investigating questions having to do with the administration of the custodian of alien enemy property, to subpoena C. George McCullagh, the editor of the Toronto Globe and Mail, to substantiate if he camand he cannot—the vile, foul, malicious, meretricious statements contained in that editorial.

Mr. A. L. SMITH (Calgary West): I also rise to a question of privilege, speaking as a member of the public accounts committee, to inform hon, members of this house that under the able chairmanship of the hon. member for Halifax (Mr. Isnor) that committee is quite capable of carrying on its affairs without direction from the minister or his loquacious assistant.

Mr. MACKENZIE: My hon. friend apparently is unacquainted with the rules of parliament, which provide that any member of the commons, private member or minister, has the right to appear before any standing committee of this house and make an appeal to that committee, because a committee is only the creature and servant of parliament; and the committee then decides.

Mr. SMITH (Calgary West): Then appear before the committee and make application; we will hear you.
