# Inquiries of the Ministry

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): Mr. Speaker, perhaps the inquiry of the hon. member was prompted by a story which appeared in the *Globe and Mail* two days ago, in which it was intimated that a favourable decision might be forthcoming in this matter.

We are still considering this proposal and may be for a short while yet, and I want to tell my hon. friend why. The benefit is almost 71 per cent applicable to recreation as against other uses, in other words the purposes of flood control, avoidance of possible flood damage, and so on. I am going to admit very frankly that this heavy proportion of recreational use applicable under the act is worrying my officials. It has been suggested, and it was suggested in the article, that there might be a division of responsibility among the first, second and third phases and the final phase, and we are looking into that matter now.
