### SALE OF CANADIAN ARSENALS PLANT

### Question No. 123-Mr. Caouette:

Has Canadian Arsenals Limited sold its plant at Salaberry and, if so, (a) why was the plant sold (b) what was the price of the sale (c) was the price set by experts (d) what were the advantages of the sales for the crown corporation (e) was it the board of directors who decided to sell the plant (f) was the decision approved by the governor in council (g) does the corporation intend to sell other plants (h) what are the terms of payment (i) were there any tenders and, if so (i) who were the tenderers (ii) what was the amount of each tender (j) to whom was the plant sold (k) what criterion was followed in the choice of the purchaser?

Hon. C. M. Drury (Minister of Industry): Yes. (a) To relieve the Crown of the cost of maintaining the plant solely for military purposes, to increase employment, and to stimulate the economy of the area. (b) \$1,757,000. (c) The price was established by negotiation between the purchaser and the Department of Defence Production. (d) A condition of the sale was the retention of military capability. The Crown was, therefore, relieved of the cost of maintaining such capability. (e) The decision was taken by the Department of Defence Production and concurred in by the
