In view of the strong statement made this week end to the automobile companies in the United States asking them to hold their prices because of their high profits, is the minister considering making a similar statement in Canada?

**Hon. Ron Basford (Minister of Consumer and Corporate Affairs):** Mr. Speaker, the operation of the automobile agreement falls under the jurisdiction of my colleague the Minister of Trade and Commerce, and I think the question should be directed to him.

**Mr. Saltsman:** A supplementary question, Mr. Speaker. In view of the responsibility of the minister of consumer affairs for prices to consumers, I was wondering whether he would care to make a statement.

**Mr. Speaker:** Order, please.

**Mr. Saltsman:** Then I will direct my question to the appropriate minister and ask him whether he intends to make a statement regarding these prices in Canada.

**Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce):** Mr. Speaker, I think we should first know what will be the prices of automobiles in Canada. If there is an increase, then I think we should give it some study before making any pronouncements on the subject.

**Hon. George Hees (Prince Edward-Hastings):** A supplementary question, Mr. Speaker. Would the minister admit that it would then be too late to do anything?
