to the Minister of Industry. Has the government any plans for easing the impact of the Kennedy round tariff reductions on companies whose products are sold only in the Canadian market? If so, when does the government expect to announce such plans?

Hon. C. M. Drury (Minister of Industry): Mr. Speaker, consideration has been given to this question. Plans are in preparation and when appropriate an announcement will be made.

Hon. Théogène Ricard (Saint-Hyacinthe-Bagot): A supplementary question, Mr. Speaker. Could the minister say whether there are any plans to protect the agricultural products of Canada?

Mr. Drury: Mr. Speaker, I point out that such products are not within my province, and I prefer not to be too precise on that.

Mr. Roger E. Régimbal (Argenteuil-Deux-Montagnes): A supplementary question, Mr. Speaker. In view of the fact that one of the consequences of the Kennedy round tariff adjustments might well be to create unemployment in certain industries, has the Minister of Industry consulted with the minister of manpower for the purpose of setting up a crash program to accelerate the retraining and relocation of the employees affected by those changes?

Mr. Drury: Mr. Speaker, such discussions have been held.

[Later:]

Hon. E. D. Fulton (Kamloops): I should like to direct a question to the Minister of Trade and Commerce or to the Prime Minister. It is related to an earlier question directed to the Minister of Industry with regard to the Kennedy round. Can the Minister of Trade and Commerce or the Prime Minister assure us that studies are being undertaken by the government to look into the possible alleviation of the impact of the Kennedy round on agriculture, such as are now being undertaken with respect to other segments of the economy? After all, agriculture is still an industry.

Hon. Robert Winters (Minister of Trade and Commerce): I shall have to speak to my colleagues about that, Mr. Speaker.
