# Mr. Jim McNulty (Parliamentary Secretary to Minister of Labour): 1. \$365 (Queen's Printer charges for time, plates and stock.)

- 2. 3,565 copies. Distribution: Daily and weekly press, independent journalists, 1,205; Labour publications, union officials, 220; Press gallery (Ottawa), 154; M.P.'s and Senators, 600; Federal government departments and agencies (e.g. U.I.C., Manpower Centres, etc.), 556; Provincial government, labour departments, etc., 63; General business and industry, 546; Universities and industrial relations institutes, 72; Total, 3,416. Unit cost of production—10 cents.
- 3. (a) and (b) Text contains no material difference except pages 14 to 16 dealing with the vote structure were not included in the minister's statement in the house because every member of the Committee had a printed copy of the revised estimates 1968-69 before him; the vote structure and other financial implications referred to in the text were self evident from the printed estimates.

- 1. Does the Department of Indian Affairs and Northern Development issue documents which are of the nature of press releases, press communiques, news releases or the like and, if so, how many such documents have been issued since July 1, 1968?
- 2. What has been the cost of (a) printing headings or cover sheets (b) typing the stencils (c) mimeographing or other form of duplicating (d) collating and stapling (e) addressing and mailing the said documents?
- 3. With respect to the paper used for the said documents, what is (a) its quality (b) the quantity used and the cost thereof?
- 4. What is the estimate of the number of manhours consumed in the preparation, production and distribution of such documents?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. Yes—104.

2. (a) \$435 approximately; (b) Nil—Stencils are not used. Releases are printed by off-set process directly from a repro-copy; (c) and (d) \$3,205.55 approximately; (e) The addressing process is done in one location for the whole department. Addressing releases is only a small part of this operation and no cost assessment is available.

The department is charged annually by post office for all postage cost on a bulk payment basis. It is not possible to assess the cost of mailing releases. However, releases are distributed by hand to the press gallery and other news media in Ottawa. Cost of this service amounts to \$423.
