TRANSACTION BETWEEN GOVERNMENT AND GEOFFREY STIRLING

Mr. Donald MacInnis (Cape Breton-East Richmond): Mr. Speaker, I should like to ask the Acting Prime Minister whether representatives of the C.R.T.C. discussed the ethics of any transaction between Geoffrey Stirling and a minister of the Crown.

Hon. Paul Hellyer (Minister of Transport): Mr. Speaker, I really do not know, but I will refer the question to the responsible minister.

Mr. MacInnis (Cape Breton-East Richmond): Mr. Speaker, I would think the Acting Prime Minister should be responsible. However my question is this: Why is it that the minister who had this question put to him several months ago did not come up with an answer? I suggest this question cannot be ruled out of order because the ethics of a cabinet minister are of urgent national importance. I ask just what he is hiding.

Mr. Speaker: Order, please.

Mr. MacInnis (Cape Breton-East Richmond): I rise on a point of order, Mr. Speaker, because of the urgency and importance of the ethics of any cabinet minister. This is a question which has been before this house on a number of occasions. If the ministers in the cabinet do not feel the ethics of any of their colleagues is their responsibility, then I think it is time this government took the responsibility and came forward with the truth. Mr. Speaker: This is not a point of order. The hon. member knows similar questions have been raised before. My feeling has always been that if a member wishes to make a charge against another member on one side of the house or the other there is a way to do it, according to the rules. For the protection of all members on both sides of the house I think we should adhere to the rules in this regard.
